



Personally Administered Drugs and Appliances (PADM) Claiming

A personally administered medication (PADM) is a prescription item prescribed and administered by a member of the practice team.

Eligible products would be listed in the NHSBSA DM&D <u>Dictionary of medicines</u> and devices (dm+d) | NHSBSA. The DM&D dictionary indicates whether the product and pack are classed as a personally administered item using the PADM indicator under "Prescribing Information" which states the product "attracts an administration fee." If you are unsure if anything is claimable, use the DM&D Browser or email NHSBSA.

Only the following products can be claimed:

- (a) vaccines (including oral vaccines), anaesthetics and injections;
- (b) diagnostic reagents: Dick Test; Schick Test; Protein Sensitisation Test Solutions; and Tuberculin Tests (i.e. Koch Test, Mantoux Test, Patch Test and Diagnostic Jelly);
- (c) intrauterine contraceptive devices (IUCD) (including drug-releasing IUCDs, contraceptive caps and diaphragms);
- (d) pessaries which are appliances;
- (e) sutures (including skin closing strips).

No payments are payable for products that are:

- centrally supplied e.g. as part of the national vaccination schedule (these are ordered via Immform)
- not supplied and administered by a GMS practice e.g. issued on a prescription

When to use FP34 or FP10:

FP34: High-volume personally administered vaccines, which can be claimed via the FP34 form. Applied only to the following vaccines (or a combination of these):

- influenza
- typhoid
- hepatitis A
- hepatitis B
- Meningococcal

FP10: Any other personally administered items should be claimed for on an FP10 prescription form (green).







If medication/appliance is not claimable under PADM:

If the vaccine/implant that is to be administered is not claimable in the practice PADM account, then the practice will need to issue the prescription to the patient who can collect the vaccine/ implant from the pharmacy and return it to the practice to be administered.

Where to post claims to:

Claims are to be posted to (except if posting digitally):

If FP10 prescriptions items are written on the FP34 appendix form, they will be disallowed and returned to the practice. Any queries email NHSBSA nhsbsa.prescriptionservices@nhsbsa.nhs.uk

MYS electronic submissions

A digital portal is available for a practice to register to upload the appendix forms, (submission document and prescriptions will still need to be posted, even if there are no prescriptions).
